**Sunday, September 2nd (rain date Monday September 3rd.) Labor Day Weekend festivities at Little Bennett.** Jim and Maureen Henry will lead a ride at Little Bennett – Montgomery County. They will lead a fast ride and are looking for a volunteer to lead a slower group. After the ride they will have a Texas style BBQ pot luck. Jim and Maureen will provide beef brisket. **Sunday, September 23rd. Antietam Battlefield.** This is a first for TROT. Several members have asked about having a ride at Antietam, but until now we never had a leader who knew the area. Katrin Boniface, who we met at the TROT booth at the Expo, agreed to become a TROT member so that she could lead a ride for us. The ride will leave either from Katrin's farm or from the battlefield if we can get a permit. Riding from Katrin's farm is about a 3 hour ride. The biggest challenge with this is that the horses must be traffic safe as they will be required to cross Sharpsburg Pike (not as scary as it sounds.) and a good portion of the way is on back roads without a lot of traffic. The ride would also ride along the C&O canal for about a mile. The terrain is mostly pavement with some stretches of gravel, and occasionally some grass. There is the possibility of doing a canter along the canal. The battlefield itself is pretty slow paced, but it's nice to be able to read the signs. About an hour of the ride is actually in the park.

There may be the possibility of parking at the battlefield. We won't know until closer to the ride date. The upside to this is that aside from the statues, there is very little in the park to spook a horse and would allow more time in the park itself. Riders could either follow the "tour route" which is all paved, or explore the gravel areas which you can't get to by car. This would be a 2 hour morning ride, lunch break, and then an optional extra hour on the somewhat harder tracks. ## RIDING IN MONTGOMERY COUNTY PARKS

What would you do if you were trail riding and came upon a group of hikers? Would you offer to get off the trail to let them pass? This happened in Rachel Carson Conservation Park, and the hikers were a group of naturalists examining some rare plants. The naturalists were upset that the horses would possibly trample the plant life. So, as a re-

minder – please be sure to stay on the trails. In situations where someone must get off the trail, walkers should give way to the horses. Also, it is very important (and Rachel Carson Park is a good example) that you know what trails are open to horses. The trails are not always marked with “No Horses” signposts. Everyone should go to the Montgomery County Park website ([www.mc-mncppc.org/trails/trail\\_maps.shtm](http://www.mc-mncppc.org/trails/trail_maps.shtm)) to get a map of the park before riding. ## TROT Board Meeting June 5, 2007

The meeting was held in Woodbine, MD, attendees were Priscilla Huffman, Pat Talbott, Pat Oliva, Marilyn Miller, Peggy Bree, Nancy Osgood. Highlights of the discussion:

**Judged Pleasure Ride.** Priscilla expressed gratitude to Marilyn Miller and all the volunteers that helped with the JPR. Seventy-one horses participated, and about 50 people pre-registered. Several lessons-learned items were discussed.

**County Coordinator Updates.** Pat Oliva (Howard County) is still pursuing membership in the Parks and Recreation Board, and identification of equestrian trails in the Western Regional Park.

**Newsletter.** Because many people do not seem to be getting the Newsletter, it was decided to send hard copies to all members, with the idea that they may indicate if they wish to only receive electronic notification that it is available on the website. The board agreed that regular classified ads should be free for members.

**Trail Ride Update.** The upcoming riding events were discussed. Possible events for next year include a joint event with the Therapeutic Riding Center and the Quarter Horse group at the League, and a cancer benefit ride.



**Maryland Trail Book.** Peggy Bree made a presentation regarding the possible development of a Maryland Trail Book, that would have detailed information for a range of equestrian trails throughout the state. The board discussed the possible market for such a book among TROT members. The board recommended that the project be deferred, due to the large effort envisioned in producing and publishing such a book.

### **NEWS FROM THE TROT MOUNTED SEARCH & RESCUE TEAM.**

The TROTSAR Mounted Team received a letter of appreciation from the City of Damascus, for public information services and safety seminars provided during the City's 2007 Preparedness Day Fair. The TROTSAR Mounted Team received one dozen multi-channel VHF handheld radios that were transferred from the US Department of Homeland Security. These radios will expand the team's communications capability between local, state, federal and non-government authorities during a search emergency or incident. Tomi` Finkle, the team's commander attended the 2007 National Conference for the National Association of Search and Rescue

(NASAR) in Charlotte NC. A full day of the conference was devoted to the development of Mounted Search and/or Rescue (MSAR) standards that is under the development and oversight of ASTM International. Tomi` is a member of 3 MSAR work and task groups. She has recently been selected to serve as the ASTM Technical Point of Contact (TPOC) Chairperson of the international standards for civilian search and rescue.
