President's Message

The Maryland 2010 Legislative Session ended April 12. This year there were six bills attempting to expand Sunday hunting. In recent years there have been numerous attempts to open the State to Sunday hunting. When initial attempts failed, bills were written for specific counties, usually in the more rural sections of the State. Some of these bills have been successful at nibbling away long standing laws by granting exceptions. This year, there were five bills directed at Allegany, Garrett, Calvert, Talbot and Baltimore counties to extend Sunday hunting. All passed except the one for Baltimore County. On-the-other-hand, House Bill 1518, which would have almost assuredly extended Sunday hunting to most of the State, died in committee.



Sunday hunting may not be a safety concern for citizens in the open spaces of western,

southern and the eastern shore of Maryland, but in the highly populated areas of central and northeast Maryland, it is a serious concern. In November we were reminded of the danger when a VA student was shot and killed on campus by a hunter on private property. Weekends are when most citizens are able to enjoy their public lands. Hunting seven days a week simply ignores the interests and concerns of the general public.

I know some insist that the government should not restrict hunting on private property on Sundays. This is a philosophical stance but has no bearing on the real world. Bullets and arrows do not stop at property boundaries

Most park users acknowledge the need to address the exploding deer population. Managed hunts with sharpshooters, extending the number of allowed kill or extending weekday hunting are possibilities. But denying the public safe and tranquil use of public recreation areas seven days a week is not acceptable.

TROT Sunday Hunting Survey Results

On March 25, The TROT Board sent out an email survey to the membership. The email went to the three hundred and seventy email addresses on file in our Membership database. If you did not receive the survey, please send your email address to <u>trotmembers@hotmail.com</u> so that you will receive future email.

The purpose of the survey was to let the Board know if the current membership was in favor of TROT continuing its longstanding opposition to the expansion of Sunday hunting. The email survey was sent to all memberships where we had an email address. Of the 370 surveys sent, we received 159 responses, which is a phenomenal response rate of 43%.

of TROT continuing its longstanding opposition to the expansion of Sunday hunting. Seven responses (4% of responses received) were opposed to TROT taking a position on Sunday hunting. Four responses (2% of responses) were Neutral/had no opinion.

On April 6, the TROT Board met and voted. The results were 10 in favor of continuing opposition to Sunday hunting and 3 abstentions. Letters on behalf of TROT were sent to State Delegates in Annapolis to voice our opposition to bills that extend the number of Sunday hunting days.

On behalf of the TROT Board of Directors, thank you to those taking time to respond the survey.

Of the 159 responses, 148 (93% of responses) were in favor

Due to limited space, listed below are some of the pro comments and all of the con comments we received in the survey. I think you will enjoy reading them.

TROT Survey Responses and Comments

"Do you want TROT, as an organization, to continue its longstanding opposition to the expansion of Sunday hunting (opposition to HB1518) for the reasons stated above?"

Question	Comments		
Yes	While it would appear that landowners should be able to use their land as desired, weapons create a different scenario especially in rural areas where woods comingle so that no one is positive where property lines are. Plus it is easy to get confused Therefore during hunting season I feel at risk walking on my own property fearing someone might easily by mistake shot across my line. Sunday is the only day during hunting season that we can use without fear our woods. Emphatically against.		
Yes	Absolutely, continue the opposition. Why should we bother to show up at public meetings and hearings to preserv trails if we can't use them at least one day during the weekend during hunting seasor Protecting access to and safety on trails is at the core of TROT's mission.		
Yes	Agree with the fairness of access concept for all recreational users - as our recreational areas continue to be destroyed by development, all users of outdoor recreational areas must work together to share them. Although not a fan o hunting, I understand giving up some time to that sport, just as I understand the need to teach my horse to be toleran of gunfire, cyclists, joggers and what not. All of the other recreational activities can safely share facilities together Hunting, no matter how responsibly it is done, is not compatible with other uses. Thank you for soliciting my opinion.		
Yes	Although the deer population is getting out of hand, and although the hunters should be able to enjoy their sport over the weekends, it is still only fair that the other outdoor users be able to enjoy the fields, trails and woods in quiet conditions.		
Yes	Are they crazy! Someone will definitely get killed. I was a hiker in Montgomery Co. and now hike & ride in Harford & Balt Co. The guns near our barn are close enough- same property has private hunters w/o giving us ONE day to ride SAFELY!!		
Yes	I am a trail rider and am adamantly opposed to expanding Sunday hunting. Although there may be a lot of hunters, they are relatively few in comparison to the number of non-hunters and it is grossly unfair that we cannot safely use the out-of-doors one day a week. Even if you ride on public land, there is always private land that adjoins it and, as demonstrated by the death of a college student in Virginia last year, it is easy for a hunter to stray onto the public land and shoot something other than a deer.		
Yes	As it stands now for 3 months we are deprived of riding safely on the Saturdays in many areas when the weather still pleasant. If Sunday hunting is passed it will deprive individuals of all weekend trail riding in many areas!		
Yes	I am very much against Sunday hunting. For much of the winter Sunday is the only day when it is safe to walk or ride in the woods. Thank you for carrying on this cause.		
Yes	Even with the best of training and intentions, accidents happen and bullets do not respect property lines. One day a week of not hunting should not be too much of a burden for hunting enthusiasts. We all have to live together.		
No	I believe the danger is overstated.		
No	I do not have much experience except this:		
	I live next to the Liberty Water shed. Hunting is limited to bow/arrow and black powder. You have to be pretty close and see your target in order to get a good shot. I feel pretty confident that I don't look like a wild animal. Most hunters are hunting very early in the morning or at dusk - not usually when I would want to ride. A 165 acre farm is across the street from my house. They shoot whenever they want 24/7. No one enforces the law. I've never asked to ride on their property because of that. Maybe TROT should educate riders (like wearing bright orange hats and vests) instead of limiting Sunday hunting. We need to be careful whenever and where ever we ride anyway.		
No	I don't think that asking to keep Sundays as a no hunting day is too much to ask it is nice to know that one day of the week is safe to go riding or hiking. Thank you.		
No	Most states allow Sunday hunting on public and private land. It is absurd for TROT to oppose Sunday hunting on private property.		
No	Since it's private property only, it should not be a problem for riders.		
No	This is a political stance. TROT is an organization that should be concerned with riding trails and getting volunteers to keep that part of the organization running smoothly. No Trails kept, no riding allowed No reason to even have TROT.

Montgomery County is facing a record \$779 million gap for fiscal year 2011, beginning July 1, 2010. Montgomery County Executive Isiah Leggett has had to make difficult choices in his proposed operating budget, including a recommended 17.5% or \$14.5 million reduction to the proposed budget for Montgomery Parks.

Big Cuts Hurt Quality Park Services

Given the size of the anticipated reduction for fiscal year 2011, Montgomery Parks will not be able to maintain services at the current level, despite the actions, reductions, and streamlining already undertaken by the department.

The impacts may include:

- Closing popular park facilities
- Reducing frequency of maintenance, including athletic fields
- Postponing new parks
- Postponing upgrades to current parks and facilities
- Reducing operating hours and response times to service calls
- Increasing park user fees
- Reducing the number of Parks staff
- Decreasing protection and management of sensitive natural areas

The budget will be finalized by May 15. If you have not already done so, please contact the County Council and let them hear from you.

Riding on the WSSC Watershed Trails

The Washington area water company (WSSC) permits horseback riding on some of its watershed areas in Prince George's and Montgomery Counties. Riders must carry a WSSC Watershed Use Permit at all times while riding the watershed trails. These permits are purchased from WSSC and are valid for one calendar year. Trail information and permits are available from the Brighton Dam Visitors' Information Center. Riders under 16 years old do not need a permit when accompanying a permitted adult.

All equestrian trails are clearly marked either by a painted symbol/blaze or by stenciled signs. Trails are located in marked areas of the wooded terrain and also along short portions of the fire access roads. Trails will be closed in wet weather to protect the watershed from erosion. Riders must not use the trails if they are wet or muddy. Riders are urged to report erosion, vandalism, or other trails issues to the Brighton Dam Visitors' Information Center. Additional information is available on the WSSC website. Editor's note: The WSSC trails are scenic and extensive, and are definitely worth the nominal price of the annual permit. We always carried our permit in the lining of our helmets – you might need to show it!

Six Farms Quarantined In EHV Investigation

The New Jersey Department of Agriculture's Division of Animal Health announced on Friday the quarantines of five Monmouth County farms and one Gloucester County farm as the investigation continues into a possible Equine Herpes Virus (EHV) outbreak.

Two horses at Sweet Dreams Farm, 463 Casino Dr., Farmingdale, were euthanized with clinical signs consistent with the neurological form of EHV-1, and another died with similar signs. Two horses had presumptive positive tests for the disease and confirmatory testing continues.

While EHV is not harmful to humans, the neuropathogenic form of the disease is often fatal to horses and is spread quickly from horse to horse.

"Quarantines are necessary to ensure that this serious disease does not spread," said New Jersey Secretary of Agriculture Douglas H. Fisher. "Our investigation is continuing as we work to protect the health and safety of horses in New Jersey and other states."

Included in the quarantine are Never Ends Farm, 384 Conover St., Howell; 266 Lanes Mill Road, Howell; Riata Man Ranch, 27 West Farms Rd., Howell; 43 Charleston Springs Rd., Millstone; and 780 Heritage Rd., Sewell. These loca-

SIMPLE DISINFECTION PROTOCOL

FOR EHV-1:

- 1) Thoroughly clean the areas before disinfection i.e. remove all organic material (manure, bedding, food...)
- Dilute five tablespoons of household bleach per one gallon of water (or 1 part bleach (sodium hypochlorite) and 9 parts water)*
- 3) Use this solution to spray or dip cleaned surfaces, tools, footwear, etc.
- 4) Use disposable materials or products that can be disinfected when treating sick or isolated animals
- * Disinfectants should always be mixed at the recommended concentrations, more is not necessarily better

Biosecurity Measures to prevent EHV-1 infection and <u>dissemination</u>

Large groups of horses sharing a common airspace can all be inflected by one horse shedding the virus. If you suspect that your horses have been exposed to EHV-1 or equine influenza virus, take rectal temperatures daily (normal adult body temperature is 100.5°F). Typically, horses infected with EHV-1 have a temperature of 102°F or higher. There are three major steps in preventing the dissemination of EHV-1, you can 1) reduce the risk of introduction of the disease to horses in the premises, 2) reduce the spread of the spread of infection beyond the infected premises. These are good management practices that should be implemented:

- Have an original, recent Health Certificate or Certificate of veterinary inspection on new arrivals
- Verification of vaccination of new introductions. Vaccination of new animals should be done at least 14 days be-

tions were placed under quarantine due to high risk contact with Sweet Dreams Farm or having received a horse from Sweet Dreams.

Investigations have concluded at Camelot Auction Company in Middlesex County and Handy Acres Farm in Ocean County and they were not included in the quarantine.

Equine Herpes Virus can cause respiratory problems, especially in young horses, spontaneous abortions in pregnant mares, and the neurologic form of the virus can reach high morbidity and mortality rates. The incubation period of EHV-1 clinically affected horses is typically 2 to 10 days, but in apparent infections may be spread for 21 days.

The Division of Animal Health Laboratory can test horses for EHV, either through a nasal swab or blood sample. Veterinarians should call (609) 984-2293 for further testing information.

fore entering a facility. Follow the recommendations of your veterinarian.

- New arrivals should be healthy without recent fever or other clinical signs of infection
- New arrivals should originate from a premises without history of EHV-1 infection
- Isolate newly arrived horses for 2-3 weeks (take daily temperature)
- Restrict movement to and from the isolation area
- Isolated horses should be treated, fed and cleaned last (after the resident horses)
- Isolated horses should be treated, fed and cleaned with dedicated equipment
- Use hygienic measures (gloves, coveralls, hand washing with soap, foot baths)
- Have dedicated tack material for each animal
- Avoid sharing fences, buckets, common water sources,
- Do not dip the water hose into the bucket
- Isolate sick horses (any disease)
- Always work sick horses last in you chore routine.
- Change/clean clothing after completing chores.
- Clean and disinfect trailers after each use (remove organic material prior to disinfecting)
- Changing coveralls and cleaning and disinfecting boots when moving between barns, farms can help minimize the risk of spreading all types of diseases.
- Separate horses in small groups
- Do not rotate horses from stall to stall
- · Properly dispose of bedding and leftover feed or hay

Strange Horse Laws

Just some wacky, odd, strange laws from around the US (and a few from other countries too!).

- The horse is New Jersey's state animal
- It's illegal in Marion, South Carolina, to tickle a female under her chin with a feather duster to get her attention while she's riding a horse.
- In New York City, it is illegal to open or close an umbrella in the presence of a horse.
- It is illegal to fish from horseback in Washington D.C, Colorado, and Utah.
- Tennessee prohibits riders from lassoing fish.
- A British law states that an Englishman must not sell a horse to a Scotsman.
- Horses are required to wear hats in hot weather in Rasario, Argentina.
- A fine of \$25 can be levied for flirting. This old law specifically prohibits men from turning around on any city street and looking "at a woman in that way." A second conviction for a crime of this magnitude calls for the violating male to be forced to wear a "pair of horseblinders" wherever and whenever he goes outside for a stroll.
- In Guernee, Illinois, it is illegal for women weighing more than 200 pounds to ride horses in shorts.
- In Kentucky, it is illegal for a woman to appear in a bathing suit on a highway unless she is: escorted by at least two police officers; armed with a club; or lighter than 90 pounds or heavier than 200 pounds. The ordinance also specifically exempts female horses from such restrictions.
- In London, England, law required taxi drivers to carry a bale of hav on top of their cabs to feed their horses. The law was in force until 1976.
- In Arizona, it is illegal for cowboys to walk through a hotel

lobby wearing their spurs.

- In Raton, New Mexico, it is illegal for a woman to ride horseback down a public street with a kimono on.
- In South Carolina, it is legal for adult males to discharge firearms when approaching an intersection in a non-horse vehicle to warn oncoming horse traffic.
- A misworded ordinance in Wolf Point, Montana: "No horse shall be allowed in public without its owner wearing a halter."
- In South Carolina, no horses are allowed into Fountain Inn unless they are wearing pants.
- In Omega, New Mexico, every woman must "be found to be wearing a corset" when riding a horse in public! A doctor is required to inspect each woman to make sure that she is complying with the law.
- · Pennsylvania law states: ``Any motorist who sights a team of horses coming toward him must pull well off the road, cover his car with a blanket or canvas that blends with the countryside, and let the horses pass. If the horses appear skittish, the motorist must take his car apart, piece by piece, and hide it under the nearest bushes."
- In Hartsville, Illinois, you can be arrested for riding an ugly horse.
- In the state of Queensland, Australia, it is still constitutional law that all pubs (hotel/bar) must have a railing outside for patrons to tie up their horse.
- Pattonsburg, Missouri, Revised Ordinances, 1884: "No person shall hallo, shout, bawl, scream, use profane language, dance, sing, whoop, quarrel, or make any unusual noise or sound in such manner as to disturb a horse."
- Abilene, Kansas, City Ordinance 349 declares: "Any person who shall in the city of Abilene shoot at a horse with any concealed or unconcealed bean snapper or like article, shall upon conviction, be fined."
- Marshalltown, Iowa, it is against the law for a horse to eat a fire hydrant.
