Hey guys and gals - You were terrific. Thanks so much for your support at the Recreation and Parks Advisory Board meeting on public equestrian access for Benson Branch Park. It was a long wait for the presentation. I know some of you had to leave. I was so proud of you when I turned around and asked you to stand. There was a sea of people with TROT nametags. I could see the whole board was alert and impressed by your presence. It made my short display have so much more meaning. Your comments and questions were impressive, and they showed a high level of responsibility, caring for the land, and the need for trails. Thanks – You were first class!

Mr. Feaga has had apparently leased much of the land for many years and has used part of the park for farming. He was the only speaker against the parking area. He has also developed the trails and maintained them. He boards horses, and allows certain local riders to cross his land into the park. He has been a wonderful friend to these riders and a real benefactor to the park. I was surprised at his desire to limit the use of the park. I also take my hat off to him - for all the years he has worked on the trails in the this park. The riders who are using the park are showing respect for the crops and staying on the trails. They have been a good example of responsible trail riders.

While talking with the board members, I feel we have a strong case and I will be meeting with them again. The area I chose is not wet-land, nor will it allow unlimited trailer parking. It will allow use of the park by those who live away from the farm and desire to access safely and ride on this public land.

NOTE THIS LATE UPDATE (submitted December 16): I just got home from a meeting with the Department of Recreation and Parks and Mr. Feaga regarding public access to Benson Branch. We have reached an agreement on a parking area off Rolling Road. Mr. Feaga will donate some of the field he is leasing to farm for a small parking area. There will be a gate with a lock and we will need permits and Coggins. The plan has not been approved but will be presented to the Board on December 17. Mr. Feaga was agreeable and very helpful. This plan will ease the fears he expressed at the hearing and will decrease the cost and the time involved. Let me say that never in the history of working with the Department have I seen them react so quickly. I want every one of you who took the time to come to the hearing on November19 to give yourselves a pat on the back! People can make a different and you all just proved it!

Montgomery County 2008 Highlights

Plans were approved and work began on a multi-year improvement to Little Bennett Park. A new trailer parking lot and five miles of multi-use unpaved trails will be added.

Upper Rock Creek Greenway is being extended in a multiyear project from Lake Needwood to Rachael Carson Park. This will double the length of the existing trails. Trails north of Lake Needwood will be natural surface. MORE (our mountain biking friends) is leading a group of volunteers and has begun work on the trail system near Derwood. An easement is still being sought linking Blue Mash to Rachael Carson Park.

Work continues on Muddy Brach Greenway that will provide a multi-use trail from the Potomac Horse Center to the Potomac River.

Seneca Greenway from Route 355 in Gaithersburg to Magruder Branch Park in Damascus is now open and horse friendly.

The trails leading from Hipsley Mill to Long Corner Road in both the Montgomery County and Howard County are now open and horse friendly. Ben Sugar from MNCPPC is leading a group of volunteers to perform trail work throughout Montgomery County. Major improvements have been made on the Muddy Branch Trail, Rachael Carson Park trails, Rachael Carson Greenway and Seneca Creek Greenway.

Through the efforts of Amy Kimble, TROT received permission from the Maryland Department of Natural Resources to perform routine maintenance to the trails in Patuxent River State Park. Amy organized and coordinated two well attended service days. Mary Prowell in the Long Corner Rd area; Deneen Martin in the Annapolis Rock area, and Bob Richards in the Howard Chapel Rd should also be recognized for the exceptional effort they put in to maintain these trails throughout the year.

Montgomery County Parks picked up another 44 acres of parkland from the Maryland Department of Natural Resources. Unfortunately it was acquired in trade for 8 acres out of the upper Paint Branch Park for the ICC.

Your involvement by joining us in working to protect and improve the trails in Montgomery County is paying off and is needed now more than ever. I look forward to working with you in 2009.

Riders to the Rescue

Four members of the TROTSAR Mounted Search and Rescue Team Inc. presented at the Montgomery County Preparedness Day Open House held at the MC Fire/Rescue Training Academy on Sunday October 5th. On Saturday November 1st five team members attended the Howard County Public Safety Expo at the HC Public Safety Training Center. The search team horses were exposed to all kinds of emergency vehicles; cars, trucks, ATV's, boats, motorcycles, a helicopter and large crowds of people. There was also a burning building, a car fire, K-9 Demonstrations and (very loud) Flash-Bang devices. The horse were even briefly exposed to Battery Man (who promoted the replacement of batteries in smoke detectors) and (the 6 foot tall) Sparky the FireDog. We had a display table and promoted the Hug-A-Tree program, Trail Safety, TROT information and handed out dozens of mounted team stickers. Team members Tomi' (Trot-2), Jacquie (Trot-13), Rick (Trot-17), Steve (Trot-22), Michele (Trot-23), Tim (Trot-30) and Linda Davis (Trot-102, our team photographer) repre-

Random Thoughts

Winter is a great time for trail trimming. Now that the foliage is gone, it is easy to see and get to the tree branches, briars and bushes that will close in on our trails come spring.

Winter is hunting season. Protect yourself by wearing bright orange or yellow when riding during the winter months. Reflective vests can be purchased for as low as \$4 from Amazon.com.

Does your horse need that blanket? The University of Maryland School of Equine Studies has researched that question and has written an excellent article providing good practical advice. The short answer may very well be "Yes," however many horses blanketed during cooler months provides more comfort to their caregivers rather than to the animals themselves. Horses have evolved to have an excellent built-in temperature control: a very thick winter haircoat. Horses require between 10 and 21 days to acclimatize to colder temperatures. For instance, on the first day of 35° F weather, the horse may feel cold, but over 10-21 days of similar cold weather, s/he will "get used to it" and be more comfortable. If temperatures drop and the horse is not used to the colder temperature, you will notice behavior changes including increased use of shelters if available, huddling together in groups with other horses, and lowering their heads and turning their hindquarters into the prevailing wind. These are all activities that help conserve heat. The shivering response will also occur in very cold horses, which generates a pretty substantial amount of body heat, helping to warm their critical internal organs.

Studies in Canada found that for adult horses in cold climates, the lower critical temperature, or the lowest temperature they can tolerate prior to a drop in body temperature, is approximately 5° F, provided they are well-nourished. Given time, any horse, even in Maryland, can adapt to this low temperature. For temperatures lower than that, they will quickly lose body heat and need our help in order to deal with the cold. We can help either by providing shelter, extra forage, blankets or a combination of all of the above. Shelter alone can reduce heat loss by up to 20% through protection from wind and rain!

During cold weather, the horse's hair stands on end, which creates an airspace around the horse where it can trap heat, enabling it to stay warm. This insulation will break down when the weather takes a nasty turn such as rain or wind the former causing the hair to lie flat and the latter blowing away the warm air trapped in the upstanding hair. This phenomenon can also happen when a horse is inappropriately blanketed. In other words, when a blanket with inadequate insulation is put on a horse during milder weather, it forces the hairs to lie flat, taking away the horse's natural insulation. Here are some simple guidelines that you may find helpful in determining whether or not your horse needs the protection of a blanket in climates like Maryland's:

- Horses that are clipped or kept in barns under light to discourage winter coat production should be blanketed when temperatures drop below 60° F when it is windy or rainy but not until temperatures hit 40° F or below on days without precipitation or wind.
- Horses with a moderate haircoat can tolerate temperatures as low as 30° F and if they have a heavy coat, they can tolerate temperatures down to about 20° F when conditions are mild. Wet or windy conditions increase these temperature limits, so keep that in mind when blanketing! A good indication that your horse may need a blanket is if you see it shivering, but even this can be fixed with shelter or additional forage.
- A horse that has recently moved from a warmer climate may benefit from some external help. Once they've spent the 10-21 days being exposed to the colder weather, they will adapt and need less help, but you may find it beneficial to blanket them until the next winter.
- Older horses that move around less benefit from blanketing in colder weather. Moving generates body heat which is why we often see horses' levels of exuberance rise with cold weather!
- Remove the blanket on a regular basis check to make sure your horse is not losing body condition, doesn't have blanket rubs or injuries, and is not developing a skin problem such as rain rot under the blanket. Be sure to keep the blanket clean, especially on the inside where it's in contact with your horse's skin.

When the weather is rainy, check to make sure the blanket is waterproof - you will be fighting a losing battle trying to keep a wet horse warm with a wet blanket! Place your hand under the blanket around the neck - your horse should feel nice and toasty warm and not sweaty under there!





DONOR BEWARE

Times are tough and for one reason or another some of you my find it necessary to relocate your horse to a new home. This will be a very difficult decision to make and you will want to pick the best facility available.

Whether you decide to sell, lease or donate your horse be prepared to do the research necessary to ensure that your horse finds a good new home. Find out how the proposed new facility plans to use your horse. Ask for several references and check them out. Call the local "Animal Control", Humane Society", "Better Business Bureau", and in Maryland, the "Maryland Horse Industry Board" offices and inquire about any previous complaints. You could also talk to their boarders, the local riding clubs, tack shops, feed stores and even their neighbors. Ask for the names of the veterinarian and farrier that they use and call them too. Any bad reputations will soon be revealed.

When inspecting the new facility, give special attention to the conditions of their other horses. Do they all seem healthy and well cared for? Check out the conditions of their barns, run-in sheds, fencing and fields. Is there enough good pastureland to support the number of horses that they have? Is there an adequate amount of hay and feed in storage? Are the water troughs full, clean and heated in the winter? All of the paddock areas should provide good food and water. Are the stalls, run-in shed and corrals clean and free of excess manure? Is there enough shelter for the amount of horses? Ask to see written evidence of the worming, farrier, dental and vaccination schedules. In Maryland most stables will post the license issued from the MD. Horse Industry Board in plain view.

To be certain that your horse is never given away or sold without your knowledge, neglected, abused or even slaughtered, you need to have a good written contract signed by all parties.

Be sure to include at least the following stipulations:

- 1. The new owner must send you pictures every 6 months if you cannot make visits. (Front, left, right and hind views)
- 2. Once a year they must send you a written veterinarian's

Need a ride/Share a ride!

Do you have a two or three horse trailer, but don't like traveling alone? Do you have a horse, but no trailer? TROT organizes some great trail rides throughout Maryland. It would be a shame to miss those fun times because you don't like to travel alone or because you don't have a trailer. We report verifying up to date vaccines, hoof and dental maintenance and the horses' over-all condition.

- 3. You shall have the right to visit your horse at any reasonable time. If you find your horse in what you consider poor health or living in less than desirable conditions, you have the right to take the horse immediately.
- 4. They must offer to return the horse to you first, if conditions prevent them from keeping the horse.
- 5. If the horse should ever require it, due to extremely poor health conditions, both you and a veterinarian should be called immediately and the horse should be humanely euthanized as soon as possible. Your horse should never have to suffer a painful and lingering death.

Finally: Remember that even if a facility advertises itself as a "Horse Rescue", "Therapeutic Riding School" or any other similar "Non-Profit/501 c 3" organization, there is no guarantee that your horse would receive any better treatment. While most of these organizations do good work, unfortunately there are a few scams in operation. Before you "donate" your horse to such an organization, do the same research and require the same contract as with any other proposed new facility. Your horse will thank you and you may save yourself a lot of grief. A legitimate "Non-Profit/501 c 3 will have no problem showing you a copy of the "Letter of Determination" and the associated tax ID# given to them by the IRS. A legitimate "Non-Profit/501 c 3" should also give you a "tax deductible" receipt for any amount of money or goods that you donate to them. To verify a Non-Profit's legal status you can use the following web sites, where you can enter your inquiries in several ways. If your Non-Profit is not listed on any site, you may want to avoid them entirely. You can also use the government sites to start an investigation via a simple phone call or email. Let the government "sort it out"!
