## PRESIDENT'S MESSAGE

#### TROT Wants You! By Pat Talbot

TROT Board elections will be held at our **Annual Dinner on March 1, 2014**. This is an all volunteer Board. It does not require special knowledge or abilities, just energy, dedication and an active interest in preserving equestrian trails and promoting trail riding. The Board oversees the governance of TROT. Board members tend to be our best volunteers and often lead TROT activities. Board meetings are held from 7 to 9 PM on the first Tuesday of each month.

Below are the relevant sections of our bylaws regarding the election and duties of the Board.

**Annual Meeting:** There shall be an annual meeting of the association during the first quarter of the membership year, unless otherwise ordered by the Board of Directors. The purpose of the annual meeting shall be to hear reports, and for the nominating committee to present a slate of directors for the coming year.

**Election:** The election of a Board of Directors shall take place at the regular annual meeting. Only members of legal voting age shall be entitled to vote on the slate of Board members presented by the nominating committee.

**Terms:** A Director shall serve for two (2) calendar years, beginning with the first board meeting after the regular annual meeting. The term of office may be extended an additional two (2) years if so desired by the Director. Upon completion of four years, a Director may make their candidacy known to the nominating committee and stand for reelection. To maintain office, Directors are required to attend, in person or by phone, a minimum of 75% of the board meetings held in a 12-month period.

**Duties:** The Board of Directors shall have supervision, control, and direction of the affairs of the association, execute the policies and decisions of the active membership, actively promote the association's objectives, and have discretion in the disbursement of funds. It shall also determine the minimum amount of annual dues required for membership in the association. It may adopt such rules for the conduct of its business as shall be deemed advisable, and may, in the execution of powers granted, appoint committees or agents to work on specific problems or reports. The Board shall report to the membership on its activities at the annual meeting. It shall meet on the call of the President or the Secretary or on demand of 20 members of the association.

DNR would like everyone working on the Gunpowder Falls State Park trails or other state park trails to sign up as a registered volunteer and record your hours. It's easy to do and provides the DNR staff with evidence of how much work needs to be done. Once you get to the volunteer page (link above) check "click here" next to the picture. This will take you to the sign up page. Then, each time you work on the trails, register your time in one-hour increments. DNR has requested that we send them a list of trail maintenance projects, and five areas have been identified that could use some work. As always, TROT volunteers will be available to help.

#### **Bunker Hill trail at Gunpowder Falls**

Several individuals and groups have been working on the Bunker Hill trail in the Hereford section of Gunpowder Falls park to avoid the steep step-down area near the main parking lot, and to open a complete loop on the trail. Although we can always do more work, the trail is now completely open. DNR has been instrumental in cutting a few large trees that prevented our using certain portions of the trail. We plan to schedule a TROT ride on this trail for the spring. Parking is available at the large DNR lot at the end of Bunker Hill Rd (off York).

I was born and raised in Havre de Grace, but now live in Aberdeen with my husband and two dogs. I started taking lessons at the age of 11, but was always the horse-crazy little girl asking for a pony every birthday & Christmas. I worked at Bonita Farm in Darlington for 5 years, which is where I got my first horse at 18 - a mare with her colt. I eventually had to sell the colt (one horse is expensive enough!) but re-trained the mare for eventing. I kept her for several years and then decided to return to school. I had to sell my mare, but rode other horses as they became available while I was in school - there just wasn't as much time! This year I finally finished my Masters degree in Accounting & Financial Management, and decided it was time to own a horse again. I bought Look of Hope, aka Digger, in June - he is a 5 year old OTTB (his last race was in February). I'm retraining him for eventing, but am also a volunteer with the Susquehanna State Park Volunteer Mounted Patrol (SVMP). With the SVMPs, I ride the trails and clear them when necessary, and let the park rangers know of any major issues. I also ride through the campgrounds and let the families come up and say hello to Digger - many of them have never seen a horse up close before! In addition to eventing and trail riding, my sister and I are training for a 25 mile endurance ride in April of 2014.

## TROT is piloting an adopt a trail program!

The idea of the program is to have horseback riders trim and report down trees, muddy areas, etc., on the trails that are utilized by them on a regular basis. Please maintain a very simple work log so we can coordinate time spent by our members. TROT is very interested in tracking time spent on trail work. These hours translate into dollars for the parks and shared land use trail areas. It will also give equestrians a voice at public forums in which we have a vested interest. TROT can than organize the removal of down trees, trail re-routes and chain sawing by going through land management supervisors to obtain authorization.

We are trying to avoid unauthorized reroutes and riders from simply going around down trees. We can take responsibility for our trails.

We have to realize that most trails are multi use and we need to collaborate with our fellow users.

This program can be provided throughout the entire TROT member area. In the past Montgomery, Howard, and Frederick were areas concentrated on most just because of where I lived and the time I had to devote to my mission. I have had to step down due to family responsibilities but I am still driven to see horseback riders step up and do their part to build and maintain sustainable trails.

## **BOARDING**, HORSE PROPERTY

#### **STALL AVAILABLE AT MILLHAVEN FARM -**
