## BOARD MEETINGS MINUTES

### Summary-Jan. & Feb., 2014 Priscilla Huffman

#### Trail rides

Lisa Troutman has volunteered as the trail ride coordinator for 2014. The board discussed the possibility of charging \$5.00 as a temporary one-day membership so that guests could join the ride. A list of trail rides set up so far this year will be available at the annual dinner.

#### Newsletter

Barbara Sollner-Webb volunteered lead an effort to promote more newsletter submissions from members. It was mentioned that if someone sees an interesting article online, permission does not need to be granted if the article is summarized, and a link provided for the full article.

#### Baltimore County

A potluck dinner and meeting was held November 19 with 14 people attending. Several TROT members have registered as MD Dept of Natural Resources volunteers for Gunpowder Falls State Park.

#### Carroll County

The Carroll County Equestrian Council would like to partner with TROT for trail clearing projects. A joint meeting will be scheduled at a future date.

#### Prince George's County

Rocky Gorge trails were opened by WSSC for one day only, Saturday January 4, and several members rode the trails. TROT provided testimony at a WSSC board meeting on December 18 requesting that the trails be left open during the winter months.

#### Montgomery County

The County Executive has declined funding for the North Branch Trail Project which would have provided a paved multi-use trail from Lake Frank to the Olney area. With the denial of funds, TROT would like to see an improved natural surface trail built at a fraction of the cost.

A horse camping area is planned for the summer at Little Bennett Park near the Prescott Rd trailer parking area. The plan, to be completed by the Boy Scouts, will have three campsites and running water nearby.

Maryland Bills HBO138 and SBO309 would decrease the archery hunting safety zone size from 150 yards to 50 yards from a dwelling house, residence, church, or other building. If passed, the bill takes effect July 1, 2014.

The Agricultural Farm Park has agreed to locate a porta-potty near the horse trailer parking area from April through November. The facility will be funded by TROT.

#### Howard County

The porta-potty facilities by the arena have been locked although they were open last winter. Facilities are still open at the playground area. TROT will contact Howard County parks to get more information.

#### Horse World Expo

All volunteer positions for staffing the TROT booth at Horse World Expo January 17-19, 2014 were filled. A procedures manual for booth volunteers was prepared that will be helpful for future events. The booth processed a record number of new and renewing memberships. Over 50 people signed up to get more information on the Judged Pleasure Ride.

## Board Meeting Minutes Continued

### Annual dinner

The annual potluck dinner and silent auction will be held at March 1, 2014 at the Mt. Airy fire hall. Jeff Dwyer of Ebbtide Stables in Anne Arundel County will be the guest speaker. TROT logo clothing will be available for sale, and orders can be taken for other logo items. Drawings will be held for six gift baskets. The new board for 2014 will be voted on by the general membership and proposed officers introduced.

### Judged Pleasure Ride

June 7 was proposed and voted on as the rescheduled date for the JPR. The event will be held at Ebbtide Stables in Anne Arundel County with June 14 scheduled as the rain date. Riders will go out in regular intervals. *[Since that meeting, the JPR has been postponed.]*

### Contact management software

The board approved a six-month trial for Constant Contact which will allow for e-mail reminders to more easily be sent to all members.

### Adopt-A-Trail project

The board approved this trail maintenance project for another year. A proposal has been received from the Mid Atlantic Off Road Enthusiasts (MORE) regarding assisting and providing equestrian input for a new multi-user trail system in the northwest part of Patuxent River State Park. A kick off meeting with MD Dept of Natural Resources will be scheduled in the next few months. Amy Kimble would like people to contact her who would be interested in helping work on the barn at the Greentop area at Catoctin.

## MARYLAND LEGISLATION

### Hunting Bills Being Considered in Annapolis Ron MacNab

Each year the Maryland Senate and General Assembly consider a large host of hunting bills. In earlier years the Bills tended to be increasingly restrictive, in recent years, primarily due to the over abundance of deer, the pendulum is swinging the other way.

For most trail riders and fox hunters, the concern has been to keep Sundays free of hunting while realizing the need to control the deer population. The Maryland Horse Council (TROT is a member) has been lobbying to allow DRN to extend the hunting season as necessary, while restricting Sunday hunting. This solution provides the means to satisfy all but the most intransigent of stakeholders. Never-the-less, the flurry of Sunday hunting and related bills continue.

This year there are eighteen bills that could directly or indirectly affect trail riders. The range of bills includes Sunday hunting by county, Sunday hunting statewide, decreasing archery safety zones around houses, churches or other buildings occupied by humans . My personal amusement favorites are allowing bow hunters to carry handguns for their personal protection; and of course the one charging a misdemeanor that brings a \$500 fine to anyone (other than hunters) who put out food for deer. Those are hard ones to top.

HB 138 / SB0309 Montgomery Establishes for archery hunters in Montgomery County a safety zone of 50 yards within which archery hunting may not take place except under specified circumstances. The former limit was 150 yards

HB 196 / SB0192 Anne Arundel Requiring the Department of Natural Resources to establish by regulation a fall turkey season for the portion of Anne Arundel County lying south of MD Route 214; and requiring the dates and bag limits for the fall turkey season established under the Act to be consistent with the dates and bag limits established for the fall turkey season in Allegany County, Garrett County, and Washington County.

HB 197 / SB0191 Anne Arundel Authorizing the Department of Natural Resources to allow a person to hunt deer on a Sunday on private property in Anne Arundel County from the first Sunday in October through the second Sunday in January of the following year, inclusive, subject to specified provisions of law.

HB 262 / SB0231 Statewide Prohibiting the Department of Natural Resources from restricting specified licensed bow hunters from openly carrying a handgun under specified circumstances.

HB 406 / SB0472 Allegany, Garrett, Washington Authorizing the Department of Natural Resources to allow a person in Allegany County, Garrett County, or Washington County to hunt any game mammal on a Sunday on specified public and private land during the open season for that game mammal.

HB 432 / SB0473 Allegany, Garrett, Washington Authorizing the Department of Natural Resources to allow a person to hunt deer on a Sunday on specified property from the first Sunday in October through the second Sunday in January of the following year, inclusive, in Allegany

County, Garrett County, and Washington County subject to specified provisions of law.

HB 669 Harford Requiring the Department of Natural Resources to include in the deer muzzle loader season a minimum of 2 days in January for the hunting of both antlered and antlerless deer in Harford County.

HB 670 StatewideThis bill establishes a statewide archery hunting safety zone of 50 yards from a dwelling house, residence, church, or other building or camp occupied by human beings. Currently, a 50 yard safety zone only applies in Carroll and Frederick counties.

HB 671 StatewideAuthorizing a person to hunt deer on private property on any Sunday during the deer bow hunting season, subject to specified provisions of law.

HB 672 Harford Authorizing a person to hunt deer on private property in Harford County on any Sunday during the deer bow hunting season, subject to specified provisions of law.

HB 673 Harford Altering the size of the safety zone for archery hunters in Harford County within which archery hunting may not take place except under specified circumstances.

HB 675 StatewideEstablishing that the Department of Natural Resources may require an applicant to provide only specified information on an application for a recreational hunting or fishing license; altering the information that a request for information from a recreational hunting or fishing license application made by the Child Support Enforcement Administration of the Department of Human Resources to the Department of Natural Resources is required to contain; etc.

HB 759 Calvert Authorizing the Department of Natural Resources to allow a person to hunt deer on a Sunday on private property in Calvert County from the first Sunday in October through the second Sunday in January of the following year, inclusive, subject to specified provisions of law.

HB 769 StatewideEstablishing that the Department of Natural Resources may require an applicant to provide only specified information on an application for a recreational hunting or fishing license; altering the information that a request for information from a recreational hunting or fishing license application made by the Child Support Enforcement Administration of the Department of Human Resources to the Department of Natural Resources is required to contain; etc.

HB 860 StatewideProhibiting a person from using food, salt, or other mineral-based attractants for the purpose of attracting deer except under specified circumstances; authorizing a person to use food, salt, or other mineral-based attractants to attract deer for the purpose of lawful hunting activities or specified population control activities; and providing for a fine of up to \$500 for violation of the Act.

HB 890 StatewideRepealing specified provisions of law authorizing deer hunting on private property on specified Sundays in specified counties; authorizing the Department of Natural Resources to allow a person to hunt deer on private property on specified Sundays; making the Act an emergency measure; etc

HB 1133 StatewideEstablishing for archery hunters in St. Mary's County a safety zone of 100 yards within which archery hunting may not take place except under specified circumstances.

HB 1356 StatewideProhibiting the Department of Natural Resources from restricting licensed bow hunters who are at least 21 years old from carrying a handgun for personal protection.

### APRIL

**Introduction to North Tract – Saturday April 5 (rain date Sunday April 6).** Ride Leader Barbara Sollner-Webb

We will have a TROT ride at the "North Tract" of "Patuxent Research Refuge" (part of the U.S. Fish and Wildlife Service, formerly known as the "Fort Meade Trails") in eastern Laurel, MD. This vast tract is part of America's only wildlife refuge devoted to research, established in 1936 by President Roosevelt, but it also offers wildlife-related activities including horseback riding, hiking, biking, etc. It is open 8 AM – 4 PM every day except federal holidays, but for use Sept to Jan, be sure to call ahead (301-497-5770) to make sure the trails are not closed because of hunting. Riding here is free but you must check in at the visitor's center.

Our ride will cover much of their almost 10 miles of rather scenic, hard-packed dirt/gravel woods trails. The ground is quite flat and EXTREMELY STURDY. Please note that these trails were originally designed to support tanks, back when the land was Fort Meade's, and they have a solid rock base covered by dirt and crushed stone; so no matter how wet the ground is, riding here does not damage the trails!! The consistency (dirt with crushed stone) is fine barefoot for all but very foot-sensitive horses, and there are no stream crossings to bother spooky horses. It is also pretty, riding through woods and out to a nice bird sanctuary-type pond.

We will likely again have 3 groups. 1) walk-only 2) walk/trot (aiming for about half-half) 3) walk/trot/canter (a good amount of trotting, but with enough walking in between to let the out-of-shape horses fully recover, and enough canter runs to be fun); plus, there are numerous sections where a sub-group can gallop on ahead if they want to.

After the (~2 ½ - 3 hr) ride, we can enjoy a pot-luck on the visitors' center outdoor seating. So please bring a dish to share! It usually is yummy!

TROT helps to secure equestrian easements or other rights of way that will permit preservation or re-routing of trails, even in areas that are undergoing new development. TROT also works closely with various county, state and national authorities to ensure that public recreational lands are open to equestrians. TROT has been instrumental in the establishment and expansion of many miles of park trails. In 2013 TROT maintained equestrian access to the WSSC watershed and to North Tract at the Patuxent Research Refuge.

TROT needs the active participation of all equestrians. Please consider being a trail ride leader in 2014. We encourage you to lead a ride on any trail system you would like to share with others. The more trails TROT knows about, especially if there are any concerns about access or trail condition, the more we can help protect them. Amy Kimble, our Adopt a Trail Committee Leader, can organize a trail clearing day prior to your planned ride to assure the trail ride will be a success. If you chose to lead a ride, you can specify the ride any way you like. This includes pace, distance and number of participants. My motto is Pick your place, Pick your pace, and Pick your space. ## TROT is piloting an adopt a trail program!

The idea of the program is to have horseback riders trim and report down trees, muddy areas, etc., on the trails that are utilized by them on a regular basis. Please maintain a very simple work log so we can coordinate time spent by our members. TROT is very interested in tracking time spent on trail work. These hours translate into dollars for the parks and shared land use trail areas. It will also give equestrians a voice at public forums in which we have a vested interest. TROT can then organize the removal of down trees, trail re-routes and chain sawing by going through land management supervisors to obtain authorization.

We are trying to avoid unauthorized reroutes and riders from simply going around down trees. We can take responsibility for our trails.

We have to realize that most trails are multi use and we need to collaborate with our fellow users.

This program can be provided throughout the entire TROT member area. In the past Montgomery, Howard, and Frederick were areas concentrated on most just because of where I lived and the time I had to devote to my mission. I have had to step down due to family responsibilities but I am still driven to see horseback riders step up and do their part to build and maintain sustainable trails.
