## CELEBRATE NATIONAL TRAILS DAY

**June 4, 2011**, is National Trails Day. This is the 19<sup>th</sup> year that the American Hiking Society has dedicated a day to celebrate America's magnificent trail system and its countless supporters and volunteers. Certainly there is no group of Americans that are more appreciative of these precious trails than horseback riding enthusiasts.

National Trails Day is celebrated all over the country. This year the American Hiking Society estimates that two thousand events will take place around the country, including trail maintenance, hiking, paddling, biking, horseback riding, bird watching, running, trail celebrations and more. "Dedicated volunteers, outdoor enthusiasts, trail lovers, and those new to the outdoors are truly the key ingredients to National Trails Day. "Naturally, it's a time to give back to trails and pay it forward by introducing someone new to the outdoors," said Gregory Miller, American Hiking Society president.

There are many events taking place in our area. You can find a range of events by searching on the internet. However, just to make it easy for you, I encourage TROT members to participate in one of the local trail work days that are scheduled to honor National Trails Day. These events are:

Liven up your trail riding by exploring new places. Most of us have our routine riding places. They are close by, reasonably well kept and provide a nice outing. Unfortunately after years of repeated use they begin to lose their attraction. In my case, I frequently go to Agriculture Farm Park and Schooley Mill Park. Both are wonderful places to ride, but I can picture them in my sleep and often do. I love them, but I am tired of them. This year I am committed to visit some of the less used trails. I won't be pre-riding and primping the trails. If there are down trees, so be it. We will cut and clip our way through or around them.

# Montgomery County Parks Update

MNCPPC Montgomery Co. Parks are under siege from the County Executive and a few Council members on the Planning, Housing and Economic Development Committee (PHED).

In February and March, County Executive Ike Leggett attempted to push through state legislation taking control of MNCPPC Park funds and moving the MNCPPC Park Police into the Montgomery County Police. Fortunately, the rest of the County Council did not endorse the move. Not able to obtain support from the County Council, he withdrew the proposal from the Montgomery County Delegation in Annapolis. The attempt failed, but is expected to come back next year in a modified form.

Now Leggett, with the help of the County Council's PHED committee, is seeking to move MNCPPC Park programs into Montgomery County government. This would leave the Parks in charge of nature centers and mowing. Initially, this was proposed as a cost saving budget matter. When it was easily shown that it did not save money, the PHED committee suggested funding a study that would investigate the feasibility of moving the programs into County Government. The theory is, it would create management efficiencies and better service to the community.

At this writing a consultant has not been named to conduct the study, much less has a recommendation been given. However, I feel inspired and willing to enter the territory of the great eastern mystic and psychic, "Carnac the Magnificent" from the old Johnny Carson Show. As wild as it may sound, I predict that..... the study will agree with whoever funds the study. In this case, Issiah Leggett and

the PHED Committee. (Thank you, it is a special gift I have.)

In its over eagerness to take control of MNCPPC Parks, the PHED committee displayed its hand for wanting to get control of the parks. They want to sell off underused park properties for the development of moderate and low income housing.

Below is how the statement read, and how they proposed to change it.

The old Housing Element objective 4. H. provided that "Designate government-owned land, **other than parkland**, that meets appropriate housing site selection criteria for future housing development.

The new Housing Element, as proposed by the PHED Committee, says at 2.13 "**Provide underused and strategically located surplus public properties for housing** that includes housing affordable to low and moderate income households at a higher percentage than required in the MPDU program."

Fortunately, the revised statement of the Housing Element was observed by a few citizens attending the hearing who sent out the alarm. Within a day or two, following tremendous public outcry, the Housing Element statement was revised again restating that parkland would be exempt from consideration.

Without public intervention however, our parks are in jeopardy. If you are a citizen of Montgomery County, please frequent the following websites to keep posted on threats to our parks and open space.

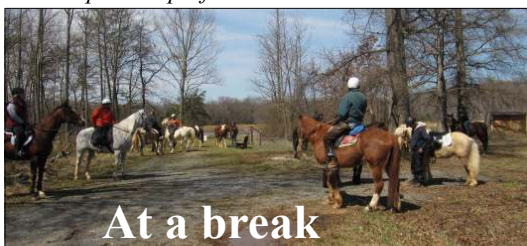
socializing over lunch and chocolate cake.

#### Montgomery County Trails Update

Now that fair weather has arrived, we are seeing winter damages on the trails. There are a number of fallen trees and limbs blocking the trails. Fortunately I haven't seen anything major that can't be easily cleared after a few work days.

Work on the new Seneca Trail continues with a hope of being completed by the end of May. A number of bridges needed to be constructed and made strong enough for equestrian use. TROT donated \$2,000 toward the construction of these bridges. Once completed there will be an approved network of trails from Black Hill Park to the

C&O Canal. The network will include the following trails; Black Hill Park, Hoyles Mill Trail, Seneca State Park (from Schaefer Farm Park to the C&O Canal). It also links to the Dry Seneca Trail which goes north close to White's Ferry Road. Many thanks to Dave Magill and volunteers at MORE for leading this effort and to Amy Kimble for leading the TROT volunteers.

In Northwest Branch, the large 40 foot bridge near the end of Lamberton Dr. has been reinstalled. The original bridge was lost in a storm last fall. Bob Turnbull from MNCPPC made this a priority project. The bridge connects the trail from Rt 29 in Four Corners to Kemp Mill Road, near Wheaton Stables. This is a well traveled trail used by the adjoining communities and equestrians.

## (She is a) Lady 1973-2011

Way back in 1994 I answered a handwritten ad that was posted on the bulletin board at the Olney Ale House. It stated, "Looking for a teenager to feed my horse when I travel." I called immediately, but did confess that I wasn't a teenager. The Lord of the Manor interviewed me and agreed that I was suitable for the job. After a year or so of feeding Lady, I worked up the nerve to ask her owner if I could ride her. His response totally shocked me. "You may have the mare and keep her here as long as you assume full care for her." We started out slowly, exploring the trails around her pasture. Even at 21, she was lively. We were so fortunate to meet Sandy (then Lewis) Boyd, who introduced us to the local horse community. I'll never forget our first group ride, we were out for a least four hours and I think we covered half of Montgomery County. Over the years, Lady stayed amazingly healthy and was able to keep up with much younger horses for lengthy trail rides. At the age of 28, she was still running away with me. At least 3 times she won the Oldest Horse Award at the **Trot Pleasure ride**. I think it was when she reached about 35, she developed chronic diarrhea and began to lose weight. I started her on Equine Senior (Southern States) and tried other supplements and top dressings but nothing seemed to make a difference. Corn oil and beet pulp didn't

seem to help. She loved to eat, but nothing was being absorbed. I last rode her this past New Year's Day. A few days later she had a bad case of colic and I thought it was the end. But a strong dose of Banamine from the vet, and she gradually improved. In early April, it was clear that she was nearing the end. She wasn't moving around much and although she loved eating her Equine Senior, she was losing more weight each day. I made arrangements with the vet to put her down on April 25<sup>th</sup>, but a week before that we found that she had fallen in the aisle of the barn. I frantically drove home from work and the vet arrived just as I was pulling up to the barn. I got to say goodbye, and I was so thankful that Mike and I could be with her till the very end. She was 39 when she died.

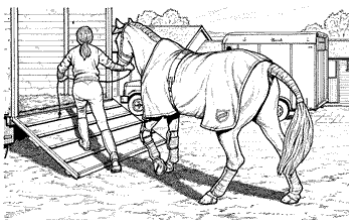

## An Important Request to ALL TROT Members, for Trail Retention

Barbara Sollner-Webb

Please, be willing to give 15 minutes to help TROT's  
primary mission -- preserving equestrian trails! We are  
asking ALL TROT members to write a brief letter,  
requesting WSSC to not close a beloved riding venue -- the  
spectacular 18 miles of equestrian trail along the Rocky  
Gorge Reservoir (at the Patuxent River, in Montgomery  
and Prince George's Counties). Many of you know or have  
ridden these lovely trails, as for ages we have had an annual  
TROT ride there, plus occasional work days to maintain  
them.

For decades, WSSC has generously let equestrians  
enjoy year-round riding on these trails -- which have  
been contoured in an environmentally sensitive  
manner. And over these many years, the trails have not  
shown appreciable erosion, nor generated other problems (at  
least to the best of our knowledge). Indeed, WSSC's  
previous Watershed Patrols called us riders their "eyes and  
ears", and they appreciated that the riders frequently pick up  
trash left by others. WSSC even dedicated this equestrian  
trail to TROT's Terry Ledely, for her over 20 years of help.

Thus, TROT members were shocked to recently learn that  
WSSC's new General Manager has proposed closing these  
long-term equestrian trails. The notice says that riding  
would instead be moved to sections of their "access  
roads" (commonly called "fire-break") where riding  
was previously forbidden because much of it is extremely

steep. Indeed, large sections of the firebreak have deeply  
eroded ruts, some hills almost impassably so, plus there are  
a few total wash-outs of this road. Riding this deteriorating  
firebreak would surely exacerbate its erosion yet further,  
contrary to sound trail management (and would be lots less  
enjoyable, being so very steep). Further, they want to  
totally ban riding for over 1/3 of the year. Discussions with  
four WSSC officials going up their hierarchy failed to  
reveal any environmental or other basis for this  
major policy change (except that one official evidently  
dislikes horses). These officials all advocated that we make  
a strong appeal directly to WSSC's General Manager, to  
show wide community interest and try to get him to change  
his mind.

WSSC has traditionally been a customer-oriented agency  
that is responsive to reason. Thus, our best chance is to  
urge all caring TROT members to write WSSC's General  
Manager [mail: Mr. Jerry Johnson - GM, WSSC, 14501  
Sweitzer Lane Laurel, Maryland 20707; or e-mail addressed  
to Mr. Johnson at [Cust-Relations@wsscwater.com](mailto:Cust-Relations@wsscwater.com)] asking  
him to reconsider these proposals to: (1) ban equestrians  
from their proven environmentally sound trail location and  
move riding to the very steep, badly eroding firebreak and  
(2) ban riding for over 1/3 of the year. So that WSSC  
could not construe this hopeful deluge of letters to indicate  
overuse of the trails, it could be great to say that you  
advocate keeping the trails open on principle, even though  
you do not (or barely ever) ride them.

Thank you so very much for this effort, to try to preserve a  
great riding treasure! Letters from all TROT members  
would be most helpful, whether or not you are a WSSC  
customer.

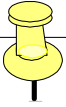
