## **TROT Ride - Introduction to North**

**Tract** – Saturday March 31. Ride Leader *Barbara Sollner-Webb* 

We had a very nice North Tract ride on March 31, as the kick-off for TROT's 2012 organized trail rides. Our 10 riders included Donata & John (who came up to join from far southern Maryland), Diane & Brian (introducing green horses), Terry (a founding TROT member), Ron (past TROT president), Laury, Vera, and Barbara (current TROT board members), and Sandy (another long-time TROT member). We split between walk/trot/optional canter and all-walk groups, and then enjoyed a lunch together afterwards. Despite some dicey forecasts, we had good weather with even some sun.



Also a note on rider-inflicted damage to a pedestrian-only bridge at North Tract, which was reported on the MarylandTrailRiders list. It turns out that North Tract's signs which for years had clearly identified a few paths

as pedestrian-only are no longer up. So it was an understandable error. I talked for quite a while with the ranger on duty, offered TROT's help in several aspects, and gently suggested to again put up pedestrian-only signs on those paths -- which fortunately is already planned.

But as a general rule, when one does not know if horses are permitted on a trail, it is best to ask, and if a bridge looks questionably strong, it is best to avoid it.

## WSSC Trail News Update

To All Who Care About Preserving Equestrian Trails -which is TROT's Core Mission:

Please sign the 2012 WSSC trails petition (full text posted on TROT's web site - <u>http://trot-md.org/</u>). Whether or not you signed the 2011 petition, it is critical to sign again in 2012, to show you still care.

Briefly, WSSC has closed their long-standing, environmentally sound equestrian trail (which they had dedicated to one of TROT's founding members, Terry Ledley), moved riding to their dangerously steep and Chapel in Patuxent State Park on Friday 3/30/2012. Austin Steo, Trail Conservancy, joined us after I had showed them the flood plain that currently housed the trail. Austin and I had marked two options prior to this walk so it was very helpful to have him to show them the lower option trail. I had two children that are very young in tow, so I could only show them the upper trail option, although the two kids were real troopers.

They will take the info back to Dave Powell, complete with the pictures they took along the way. I am very excited and interested to see where we go from here. Then all of us caravanned over to the Jennings Chapel difficult water crossing. They all stated my suggested re-route was the best option for the time being, now all I need is authorization from Dave Powell.

I worked on Saturday at the Little Bennet Dark Branch Trail Project. The trail is currently closed while it is rerouted. The turn out was very disappointing, 2 - 5 at most. For the first 2 hours it was just Austin and I. We did corridor clearing from where the Boy Scouts project ends toward where we connect with the existing trail for a ways. I do realize that Sceneca Bluff was being worked on and WSSC had a project but I was disappointed.

I will continue to try and work on the most needy area at the time.

I will be signing up to go to the South East Trail Conference around April 18th., so I can get the early bird rate.

#### Cedarville State Park, Brandywine, MD – Saturday, September 15, 2012, Ride leader Judie Artman

Cedarville State Forest has nearly 20 miles of lovely trails that wind their way through pine and hardwood forests with a few clearings. Most trails are single track and flat but there are a few hills, some steep. Although there aren't many rocks, a few trails have had gravel put on them, and some have exposed roots. In dry weather, the trails can be hard packed, and they can be wet in wet weather. There are some gravel forest roads that can be ridden on. There will be bridges to cross. The pace will be walk/trot with some cantering if the group wishes. Be prepared to see hikers and possibly a mountain biker or two. Please be ready to ride at 11:00am and plan to ride for about 2 hours. The grassy parking area is a nice area for a picnic, so bring chairs and a lunch. The ride leader will provide sodas and water.

Directions from Route 301 traveling from Prince George's County: From Route 301 South travel to Cedarville Road (at the very end of Prince George's County). At traffic light, take a left on Cedarville Road. As a landmark there will be a large white warehouse located on the left hand side. Take Cedarville Road to Bee Oak Road (on your right) which is the main entrance to the forest. Enter the forest, travel a mile or so, and you will see the Ranger Station on the right which has a stop sign on the road. Turn into the lot and pay the three dollar fee. (It's best to bring \$3.00 cash with you. The fee is \$4.00 for out of state residents.) Go back out to Bee Oak Road, continuing in the same direction to the next intersection and turn left. Continue a short distance and you will see a large grassy field on your left. Park there. (There is a playground across the road as a landmark.) There are bins at the edge of the lot to deposit manure.

#### **Expansion of Rock Creek Trail System**

The Rock Creek trail system consists of paved and natural surface trails. A paved trail goes from Meadowbrook Stables at the D.C. line to Lake Needwood in Derwood. This year work will begin on completing a major portion of the Upper Rock Creek trail system. Last year a natural surface section was built to connect Agriculture History Farm Park to Muncaster Mill Road. This year (now that the ICC is complete) work will begin linking Lake Needwood to Muncaster Mill Road. Once complete, one can ride from Agriculture History Farm Park (Ag.Farm) to Lake Needwood.

At the northern end of Ag. Farm there is a people's choice trail that leads to Route 108. This trail will become a sanctioned trail. I am working on a proposal with Parks for National Recreational Trails funding for two fiberglass bridges that will cross feeder streams.

This northern trail will then be extended east and link with

### Horse enthusiasts want more room to ride in Washington County parks and recreation plan

BOONSBORO — Citizens emphasized the need for more places in Washington County to ride horses during a public meeting Monday night on a proposed county plan for land preservation, parks and recreation.

A 2010 Maryland Equine Census said there were 3,750 horses, ponies, mules, donkeys and burros in Washington County, but Keedysville resident Sharon Draper said she thinks that number is too low.

Although Draper said there are many horse owners in the county, Boonsboro resident Charleen Jones said places in the county to ride horses are limited.

Jones said horses can be ridden on the Chesapeake & Ohio Canal National Historical Park, although another person during the meeting said the towpath is often "a field day for loose dogs."

Draper emphasized the need for more places to ride horses, saying many horse owners in the county go to other counties to ride.

"Washington County is beautiful. The potential is here," Draper said.

the North Branch of Rock Creek Park. A new paved trail will extend south from Route 108 through Lake Frank and connect to the paved portion of Rock Creek trail. When completed, this will be a thirteen mile loop.

#### WSSC Trail Update

WSSC has hired a consultant to study the operation of its' watershed properties at Howard Duckett (Rocky Gorge) and Tridelphia reservoirs. As of this writing, the consultant has not attempted to meet nor speak with equestrians.

#### Patuxent State Park at Route 97

Amy Kimble with the assistance of Austin Steo, President of Trail Conservancy Inc. and Patuxent Park Management have laid out a reroute of a trail away from wetlands and onto higher ground. Work on the reroute started in April and will be done by volunteers.

#### Seneca Park Trail

I understand the building of this trail is nearly complete. I have not ridden yet, so if any of you are familiar with it I would love to ride it with you.

night was the first time she had heard about the need for more horse-riding areas and said she was excited to make it part of county consideration.

The proposed county park plan, updated every six years, is a requirement for the county to use funding from Maryland Program Open Space and to comply with a federal land and water conservation law. The current update would replace a version adopted in 2005.

The plan analyzes existing park and recreation facilities, and makes recommendations for land acquisition, park development and fulfillment of recreational needs.

Monday's public hearing at the Eugene C. Smith Community Center is one of three public meetings on the proposed plan. The second meeting will be March 27 in Clear Spring and the third will be March 29 in Hagerstown.

Jim Sterling, director of parks and facilities for the county, said there has been consideration for expanded horse riding through the establishment of a trail at the Washington County Agricultural Education Center near Sharpsburg. Sterling said trees from storm damage have been shredded and saved as possible material for a trail. There also has been consideration of expanding the riding ring at the center for horse riding, Sterling said.

By bringing up the need for more horse-riding areas now, the issue can be considered for not only the long-range parks plan but for land the county currently owns, Sterling said.

One man who spoke during the meeting said horse trails can (Wahington County continued on page 8)

create problems for runners. The man said he once hurt his ankle while running on a horse trail.

Baker talked about adaptive reuses of land for recreation, like possibly using some buffer land around Hagerstown Regional Airport for walking paths. Former landfills can be used for ball fields, Baker said.

Baker said public input on a parks plan is vital because

county officials don't want to establish park facilities that people will be forced to like.

"We want this to be successful for you. We want this to be successful for the county," Baker said.



## **NEWS FLASH!!**

#### Urgent Notice: Potential Danger of Horse Hair

This is a public service announcement... In a press release today, the National Institute of Health has announced the discovery of a potentially dangerous substance in the hair of horses.
